With Unitary Authorities just around the corner, Reigate and Banstead Borough Council have been giving serious consideration as to who should own or look after Assets of Community Value once the borough council has been dissolved, currently scheduled for May 2027.

I assume that other councils will be following suite and looking to pass on community assets, if not now, then soon. The Electric Theatre is certainly regarded as a community building and historically has always been a 'sensitive subject' for Guildford Borough Council to deal with. There have been community protests over its future in the past as it's so dearly loved by many.

With the advent of the Unitary Authority, whatever form that may take, that has been foisted upon us by central government, Surrey and Guildford are at a turning point, and I feel it's opportune that an organisation with the experience of Guildford Fringe have expressed a long term interest in the future of the Electric Theatre. No one yet knows what might happen to our community assets under Unitary Authority ownership and/or control but, unless they are carefully passed on to those who care, I fear we may lose them forever.

When considering a stable future for the Electric Theatre, it's hard to think of a better more experienced, more community orientated company than Guildford Fringe. Diverse in the arts with contacts in theatre and entertainment and with more than a dozen years spent entertaining Guildford.

I have known Nick Wyschna over many years, and we worked together during and after the pandemic to make sure Guildford festivities still functioned and local traditions continued to be celebrated. To some extent Guildford, with the Wyschnas and all that they have given and still give to us, is a much better place. Nick and Charlotte's activities bring Guildford to life, and I fully support the idea of Guildford Fringe having stewardship of the Electric Theatre.

The Guildford Community have benefitted enormously from the use of a building known as the Spike for the past 19 years. Since its full refurbishment many thousands of people have used the Community Centre or come to visit the Heritage Centre (often the number one thing to do in Guildford according to Tripadvisor). Guildford Borough Council are the freeholders of the building and rent it to the Charlotteville Jubilee Trust for a peppercorn (if asked for) on a full repairing lease. This means that overheads are low and the annual surplus can go toward the building's maintenance and improvements. This arrangement has worked well for the Spike and I hope that a similar solution can be found for the Electric Theatre.
